SECOND : The award shall be valid upon the completion of the awards ceremony.

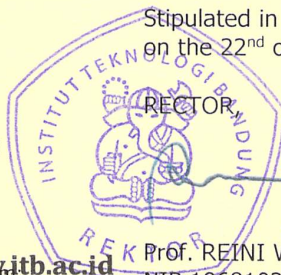
THIRD : The decree shall take effect as of the stipulated date, with the provision that in case of unforeseen changes/errors, appropriate correction will be made.
